## Dear Parent or Guardian:

The Kings Local School District Food Services Department's goal is to provide nutritious meals while contributing to the overall physical and mental well-being of your child(ren). Breakfast and Lunch service is served daily. Parents/Guardians may apply for free or reduced price meals by completing an application (attached) for free and reduced price meals. Students who were approved at the end of last year automatically qualify again this year for the first 30 school days, up to **October 1<sup>st</sup>, 2020**. If a new application is not completed AND processed by September 25<sup>th</sup>, 2019 the previous year's eligibility status is removed and the student will be returned to full paid status. Any meal charges that incur prior to the new application being submitted **and** processed are to be paid in full by the parent/guardian. This packet includes a meal application and a set of instructions for the program. Breakfast and Lunch Meal Prices are as follows:

## Frequently Asked Questions about the Free/Reduced Meals

### 1. WHO CAN GET FREE OR REDUCED PRICED MEALS?

- All children in households receiving benefits through the Supplemental Nutrition Assistance Program (SNAP), or Ohio Works First (OWF) are eligible for free meals.
- Foster children that are under legal responsibility of a foster care agency or court are eligible for free meals
- Children participating in their school's Head Start program are eligible for free meals
- Children who meet the definition of homeless, runaway, or migrant are eligible for free meals
- Children may receive free or reduced price meals if your household's income is within the limits on the Federal Income Eligibility Guidelines. (noted on the federal income chart (below)).

**2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY?** If members of your household lack a permanent address, are you staying in a shelter, hotel, or other temporary housing, relocate on a seasonal basis or, children living with you who have chosen to leave their prior family or household then the children may qualify as homeless, migrant or runaway. To inquire on information please call 513-398-8050 extension 10027.

**3. DO I NEED TO COMPLETE AN APPLICATION FOR EACH CHILD?** No, use one Free and Reduced Meal Application for all students in your household. We cannot approve an application that is not complete, so please review carefully and complete all the required information. Please return the completed application to your child's school or you can send to Kings Local Education Center, 1797 Kings Ave., Kings Mills OH.

**4. SHOULD I COMPLETE AN APPLICATION IF I RECIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE ALREADY APPROVED FOR FREE MEALS?** No, but please read the letter you received carefully and follow the instructions. If any children in your household are not listed on the eligibility notification letter, please contact Jennifer S. Arlinghaus, Food Service Director, 513-398-8050, ext. 10027 immediately.

**5. CAN I APPLY ON-LINE?** Yes, you are encouraged to complete an online application instead of completing a paper application, if possible. The online application has the same requirements and will request the same information as the paper application. Visit [www.kingslocal.net](http://www.kingslocal.net) to begin or learn more about the online application process. Contact to Jennifer S. **6. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO COMPLETE A NEW ONE?** Yes. Your child's application is only good for that school year and for the first 30 days of the new school year. You are required to submit a new application unless the school has informed you that your child is eligible for the new/current school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free or reduced meals, your child will be charged the full price for meals.

**7. I GET WIC. CAN MY CHILDREN GET FREE MEALS?** Children in households participating in WIC may be eligible for free or reduced price meals. Please fill out an application.

**8. WILL THE INFORMATION I HAVE BE CHECKED?** Yes. We may ask you to send written proof.

**9. IF I DON'T QUALIFY NOW, MAY I APPLY LATER?** Yes. You may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free or reduced meals if the household income drops below the income limit.

**10. WHAT IF I DISAGREE WITH THE SCHOOLS DECISION ABOUT MY APPLICATION?** Contact Jennifer S. Arlinghaus, Food Service Director, 513-398-8050 extension 10027. You may also ask for a meeting by contacting Matthew Luecke, Business Manager, 513-398-8050, extension 10150.

**11 MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN?** Yes. You, your child (ren), or other household members do not have to be U.S. citizens to apply for free or reduced price meals.

**12. WHAT IF MY INCOME IS NOT ALWAYS THE SAME?** List the amount that you normally receive. For example, if you normally make \$1000 per month, but you missed work last month and only got \$900, put down that you receive \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.

**13. WHAT IF SOME HOUSEHOLD MEMBERS HAVE NO INCOME TO REPORT?** Household members may not receive some types of income that we ask to be reported on the application, or you may not receive income at all. Whenever this happens we ask that you report this on the application. Whenever this is the case, please write "0" in the income section. If any income sections are left empty or blank those sections will also be counted as "0" income. Please be careful when leaving income sections blank. Review these sections carefully.

**14. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY?** Your basic pay and cash bonuses must be reported as income. If you receive cash value allowances for off-base housing, food, or clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any combat pay resulting from deployment is also excluded from income.

**15. WHAT IF THERE ISN'T ENOUGH SPACE ON THE APPLICATION FOR MY FAMILY?** List any additional household members on a separate piece of paper, and attach it (securely) to your application. Contact Jennifer S. Arlinghaus, Food Service Director, 513-398-8050, extension 10027, if you are in need of a second application.

**16. WHY AM I BEING ASKED ABOUT GIVING MY CONSENT FOR AN INSTRUCTIONAL FEE WAIVER?** Ohio Public Schools are required to waive instructional fees for children who qualify for free meal benefits. Kings Local Schools has extended that to students that have been determined eligible for the reduced meal benefit. The District must have parent consent to share student meal application if your child(ren) qualifies for a fee waiver. If you agree to allow your child(ren)'s meal application to be shared with school officials then check "YES" in Part 5. If you do not wish for that information to be shared, check "NO" in Part 5. Answering NO to this question will mean your child will not be able to be considered for a fee waiver. Answering this question either way will not change eligibility status for your child(ren).

**17. MY FAMILY NEEDS MORE HELP. ARE THERE OTHER PROGRAMS WE MIGHT BE ABLE TO APPLY FOR?** To find out how to apply for Ohio SNAP or to obtain other assistance or benefits, please contact their local office at 1-877- 852-0010

**Privacy Act Statement:** This explains how we will use the information you give us.

The Richard B. Russell National School Lunch Act requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the Social Security Number of the adult household member who signs the application. The Social Security Number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Ohio Works First (OWF) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a Social Security Number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.

In accordance with Federal civil rights law and U.S. Department of Agriculture civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who required alternative means of communication for program information (e.g. Braille, large print, audiotape, American sign language etc...) should contact the Agency (State or Local) where they applied for benefits. Dear Parent/Guardian:

If your children receive free or reduced price school meals, they **may** also be able to receive free or low-cost health insurance through Medicaid or the State of Ohio Healthy Start, Healthy Families Program. Children with health insurance are more likely to get regular health care and are less likely to miss school due to sickness.

Because health insurance is so important to the children's well-being, the law allows us to tell Medicaid and Healthy Start, Healthy Families that you children are eligible for free or reduced price meals, ***unless you inform us not to do so***. Medicaid and Healthy Start, Healthy Families only use information to identify children who may be eligible for their programs. Program officials may contact you to offer to enroll your children. Completing the Free and Reduced priced School Meals Application does not automatically enroll your children in health insurance.

If you do not want us to share your information with Medicaid or Healthy Start, Healthy Families, fill out the form below and send in with your child to their school.
